J8-18-04**BIDDING INSTRUCTIONS****1. GENERAL**

The purpose of this Invitation For Bidding (IFB) is to establish a cooperation with a supplier for **food preparation (fresh cooked meals) and special certified food package (bamboo knife and fork, plastic spoon and a napkin/per person included)**, in order to serve the needs of Multinational HQ NRDC-GREECE. It is mentioned that all the **feedstock** will be provided by the HQ NRDC-GREECE (SPT Bn) to the under bidder on time and that **the cost of food packages, transport and other relevant costs overload the supplier**. The supplier will provide his services in area of Thessaloniki "PEDION AREOS" Camp, Assiros "PROKOPIDI" Camp and Sindos "LEVANTI" Camp where HQ NRDC-GREECE will be deployed during the exercise "**Trident Jaguar 18**" [13 to 22 Apr 18 (TBC) and 31 May to 11 Jun 18 (TBC)], after contact via fax or telephone as it is determined in the technical terms.

2. DEFINITIONS

a. The term "Prospective Bidder" shall refer to the person (individual or corporate) that has completed and returned the Enclosure of the transmittal letter of this IFB, and has indicated thereon its intention, without commitment, to participate in the bidding.

b. The term "Bidder" shall refer to the bidding person (individual or corporate) that has submitted a bid in response to this IFB.

c. The term "Contractor" shall refer to the bidder to whom the contract is awarded.

d. The term "Contracting Officer" designates the official executing this invitation for bids on behalf of the NATO Rapid Deployable Corps Greece (NRDC-GREECE/J8/P&C).

e. The term "days" as used in this IFB shall, unless otherwise stated, be interpreted as meaning calendar days (weekends and holidays included).

f. The term "NATO" shall refer to the North Atlantic Treaty Organisation.

g. The term "NRDC-GREECE" means the NATO Rapid Deployable Corps – Greece, located at Thessaloniki, Greece.

3. ELIGIBILITY

This Invitation for Bid (IFB) is open to bids from every catering services company. Bidders must be legally authorized to operate, at the time of bidding and contract undersigning, this kind of enterprise.

By sending back a bid, the bidder accepts to receive a sanitary inspection in his facilities by the health services team of the CSS Division.

4. AMENDMENT OR CANCELLATION OF IFB

a. HQ NRDC-GREECE reserves the right to amend or delete one or more terms, conditions or provisions of the IFB prior to the date set for the bid closing. An amendment or amendments to this IFB shall be announced to the prospective bidders.

b. HQ NRDC-GREECE reserves the right to cancel, at any time, this IFB partially or fully. In such case no prospective bidder shall claim for payment of any sort of expenses concerning the preparing or the submission of the bid. If this IFB is cancelled prior to the bid opening, the bids already received will be returned sealed as submitted to the senders upon their request.

5. EXTENSION OF BID CLOSING DATE

No request for extension of the bid closing date will be accepted.

6. COMPLIANCE STATEMENT

a. Bidders' proposals must be based on maximum compliance with the terms, conditions, and requirements of the IFB and its future clarifications and/or amendments.

b. The bidder shall include in its proposal the compliance statement at Enclosure 1. The bidder shall list thereon, when applicable, all deviations from the provisions of the intended Contract. In case of conflict between the compliance statement and the detailed evidence or explanations/comments furnished, the detailed evidence/comments shall take precedence for the actual determination of compliance.

7. ACTIVATION SCHEDULE

The activation of the service by the Contractor shall be executed in such a way as to guarantee full operational availability of the services under the contract as of **13 Apr 18 (included)**.

8. DURATION OF THE CONTRACT

The contract awarded through this IFB will be effective from **13 to 22 Apr 18 (TBC)** and **31 May to 11 Jun 18 (TBC)**],

9. EXEMPTION FROM TAXES

According to the NATO / HQ NRDC-GREECE Technical Agreement, goods and services are exempt from taxes, duties and similar charges. A VAT (Value Added Taxes) exemption certificate will be delivered to the contractor upon payment. Where notwithstanding, these are imposed by national

regulations, bidders will enclose the list and the amounts of taxes, duties and similar charges which have been included in their bid, properly justified.

10. CONTENTS OF PROPOSAL**a. The proposal should include the following documents:**

- (1) A table of contents for the entire proposal.
- (2) Bidder's name, address, Point Of Contact, phone and fax numbers, e-mail address, and Internet site, person responsible to the national authorities of commerce and public health.
- (3) Compliance Statement for the intended contract (**Enclosure 1** hereto).
- (4) Valid licence of company operation.
- (5) Bid Proposal. The Bid Proposal shall include the **offered price per portion** based on the "**Enclosure 3**" format. The supplier should provide one firm-fixed price per portion of meal.
- (6) Valid Tax Clearance Certificate.
- (7) Valid Insurance Clearance Certificate.
- (8) List of Sub-Contractors that the bidder proposes to use in connection with the performance of the contract. In case that bidder does not use any Sub-Contractor, it shall be clearly stated.
- (9) Valid Certificate of Quality Management System where the fulfilled requirements are stated (ISO 9001).
- (10) Valid Certificate of Foods Safety Management System where the fulfilled requirements are stated (HACCP or ISO 22000).
- (11) List of performance data of at least two contracts/agreements substantially similar in scope to the requirements described in the solicitation.

b. All the above contents are obligatory except 10.a(1) and a(2). A bid proposal without a complete contents list will not be considered for award.

c. Bids that will not be submitted upon the bid proposal format and according to the instructions will not be considered for award.

11. PROPOSAL SUBMISSION

a. The whole proposal shall be written in English and handed over to NRDC-GR/J8/Purchasing & Contracting Section **no later than 22 Mar 18/14:00hrs (bidding closing date/time)**.

b. Proposals shall be submitted inside a single sealed envelope. The envelope will be marked "**Sealed Bid to IFB NRDC-GREECE J8-18-04**". The sealed envelope will be placed in another (exterior) envelope or box on which will be glued the mailing label found on Enclosure 2 to these Instructions.

c. Bids may be submitted by courier or hand-carried. Bids hand-carried to HQ NRDC-GREECE or delivered on site by commercial courier and parcel-delivery companies must be packed and labelled as indicated in paragraph above. Packages have to be handed over to a representative of the HQ NRDC-GREECE PURCHASING AND CONTRACTING SECTION in Building C in the HQ NRDC-GREECE (HQ NRDC-GREECE telephone: 2310-882685) during working days between 08.00 to 14:00 hrs. The date and the time the bid is handed over will be recorded on the envelope or package and the delivery agent will be requested to sign the date/time endorsement, signifying his agreement as to its accuracy.

12. LATE PROPOSALS

The bidder must make every effort to ensure that his bid reaches HQ NRDC-GREECE before or on the exact date and time set for the bid closing. Any Bid received after this time is considered a late bid. Late bids shall be considered only before the Contract has been awarded and on condition that their failure to arrive on time is solely the result of:

a. A delay in the government channels, i.e., governmental courier service or mail for which the bidder was not responsible. However the bid should have been sent not later than three (3) calendar days before the bid closing, by Registered Mail or by Certified Mail, for which an official Post Office date stamp or the receipt for certification has been obtained. Note: commercial courier or parcel-delivery companies are not considered to be government channels.

b. Mishandling by HQ NRDC-GREECE personnel upon or after receipt.

Other late proposals cannot be considered for award. These bids will be treated as non-responsive and will be returned un-opened to the bidder, at his expense.

13. BID WITHDRAWAL

A bidder may withdraw his bid up to the date and time specified for the bid closing, by written or facsimile notice to the HQ NRDC-GREECE Contracting Officer. The bid will be returned un-opened to the bidder, at his expense.

J8-18-04**14. BID CLOSING DATE**

Bids must be received at HQ NRDC-GREECE **no later than 22 Mar 18/14:00 hours**. At that date and time the bidding will be closed.

15. BID VALIDITY

Bids submitted shall remain valid for a period of sixty (60) calendar days counted from the bid closing date. HQ NRDC-GREECE reserves the right to request an extension of validity if a decision cannot be made within this time. Bidder will be entitled to either grant or deny this extension of validity; HQ NRDC-GREECE will automatically consider a denial as a withdrawal of the bid.

16. BID EVALUATION

The evaluation of Bids and the determination as to the responsiveness and technical adequacy of the services, products and materials offered shall be the responsibility of HQ NRDC-GREECE and shall be based on information provided by bidders. HQ NRDC-GREECE will not be responsible for searching, locating or confirming any information, which is not clearly identified and available in the bid.

Received Bids will be evaluated under two factors:

a. Sanitary Inspection (Pass/Fail) from CSS Division, health services.

b. Lower offered price per portion (only for suppliers who have passed the sanitary inspection).

17. AWARD

a. HQ NRDC-GREECE Contract Award Committee (CAC) will award the Agreement to the Bidder whose conforming proposal represents the most financially profitable solution to NRDC-GR, and demonstrates that the Bidder can fully accomplish IFB requirements.

b. HQ NRDC-GR reserves the right to negotiate the final terms and conditions of the contract before making the award.

18. CLARIFICATION OF PROPOSALS

During the entire bid evaluation process HQ NRDC-GREECE reserves the right to discuss any bid with the bidders in order to clarify what is being offered and to resolve any potential areas of non-compliance.

J8-18-04**19. COMMUNICATION AND CONTACT FOR CLARIFICATION****a. COMMUNICATIONS**

Any communication related to this IFB, between a prospective bidder or a bidder and HQ NRDC-GREECE shall only be through the HQ NRDC-GREECE Contracting Officer in the first instance. Designated HQ NRDC-GREECE personnel will assist the Contracting Officer in the administration of this IFB. **There shall be no contact with other HQ NRDC-GREECE personnel.** This is to maintain all bidders on equal and competitive footing.

b. BIDDERS REQUEST FOR CLARIFICATION

Prospective bidders should seek clarification as soon as possible. Any explanation, desired by a bidder regarding the meaning of this IFB, clauses, specifications etc., must be **requested in writing** (fax or email) from the Contracting Officer. **The Contracting Officer must receive such requests for clarification not later than 3 calendar days before the bid closing date.**

Information given to a prospective bidder will be announced to all prospective bidders, as an amendment to this IFB, only if such information is necessary to bidders in submitting offers or if the lack of such information would be prejudicial to other bidders. Oral explanations or instructions will not be binding unless confirmed in writing by the Contracting Officer.
