2. Detailed Evaluation

a. Evaluation Strategy

The evaluation was focused on the information provided by the bidders, keeping in mind the most financially profitable solution for NRDC-GR. Bids were evaluated under the factor of highest score, implementing the evaluation formula, as depicted in Enclosure '4' of Reference C, based on the free flights offered by the contractors.

b. Compliance and Eligibility.

The firms were in compliance with all subject clauses of the IFB and the intended contract and submitted all the legal documents requested in PART I "Bidding Instructions".

c. Price Analysis

The bidding data/proposals received are summarized in ANNEX "A".

Firm "GREECE ON THE GO " BUSINESS TRAVEL had the most financially advantageous offer.

3. Award Decision

Regarding the information stated above, the contracting officer awarded the contract on the bid submitted by "GREECE ON THE GO " BUSINESS TRAVEL, which has overall proposed the most benefit solution to NRDC-GR.
